- 1. Only those students who have been **selected** and paid the Govt Fees are eligible to stay in the hostel.
- 2. The payment for the Hostel fees are divided into two parts:
 - **a.** Government Fees of **Rs. 3100/-** to be paid through SBI Collect. This fee can be paid from the 18th of June 2025 onwards by following the payment guidelines.
 - b. Security Deposit Refundable (3000) + Welfare Fund Non Refundable (600) and Mess Fees @ Rs. 2300/ Month (Rs. 13800 for Whole Semester)
 - i. First Instalment (Rs.6900) + Security Deposit (Rs.3000) + Welfare Fund (Rs.600) = Rs. 10500/- and Second Instalment of Rs. 6900 in First Week of October.
 - ii. Whole Semester (Rs.13800) + Security Deposit (Rs.3000) + Welfare Fund (Rs.600) = Rs. 17400/-


